# **Quality Assurance Standards**

In September at the Annual Meeting, the OAFC will be presenting Quality Assurance Standards to the Association's members. The Association sees an importance in the continuity the level of care and access available to the underserved across Ohio. The Standards are comprised of 7 different portions, which include enhanced access and continuity, management of patient populations, management of patient care, community resources, coordination of patient care, performance measurements, and administrative standards.

Laura and Bekah, the VISTAs in the OAFC office, have created a toolkit to aid clinics in the implementation of the QA Standards and will be available to help the clinics throughout the process.
